FIIA publishes several policy-oriented and quality-controlled series, including the Finnish Journal of Foreign Affairs (Ulkopolitiikka). FIIA researchers also engage in innovative academic research and scientific collaboration, the results of which are disseminated through leading publishing houses and peer-reviewed journals.

We continuously strive to develop new and innovative ways of exploring the key issues of the day. These include important timely research themes, new conceptual approaches, or new research methods, such as strategic forecasting.

We strive to continuously reassess and critically evaluate our own work and to stay in touch with the major transformations taking place in international affairs.

FIIA's long-term funding from the Parliament of Finland, our key stakeholder, provides a solid foundation for our activities.
